Suspending the grant of subvention to some private secondary schools for the
non-respect of dispositions relating to the use of State subvention

- Mindful of Decree No. 2011/408 of 09 December 2011 to organize the Government modified and completed by Decree No. 2018/190 of 02 March 2018;
- Mindful of Decree No. 2012/267 of 11 June 2012 to organise the Ministry of Secondary Education ;
- Mindful of Decree No. 2018/191 of 02 March 2018 to reshuffle the Government modified and completed by Decree No. 2019/002 of 04 January 2019;

Considering reports on the control of the use of state subventions for the 2019 and 2020 financial years presented by the National Control Brigade for Private Secondary Schools,

HEREBY DECIDES

Article 1: From the date of signature of this Decision, the following private secondary schools are suspended from benefiting from the state subvention for the 2022 and 2023 financial years:
