To Certify the Closure of some schools for the 2023-2024 school year

THE MINISTER OF SECONDARY EDUCATION,

Considering reports of the National Control Brigade for Private Secondary Education Schools (NCBPSES) and information forwarded by the Technical Departments (DGSE, DTVSE, DTT) and external services of the Ministry of Secondary Education.

HEREBY ORDERS AS FOLLOWS:

Article 1: The following private school is hereby closed down from the date of signature of this order in accordance with the provisions of Article 24 of law n^o. 2004/022 of 22 July 2004 and of Articles 31 and 32 of decree n^o 2008/3043/ PM of 15 December 2008:
