ORDER No. 270/23 /MINESEC/SG/DAJ/DGSE/DTVSE/DTT/NCBPSES of 30 JUN 2023

To close down certain cycles and sectors in some private schools for the 2023-2024 school year for the violation of legal procedures relating to expansion

THE MINISTER OF SECONDARY EDUCATION,

- Mindful of the Constitution;
- Mindful of Law No. 98/004 of 14 April 1998 to lay down guidelines for Education in Cameroon;
- Mindful of Law No. 2004/022 of 22 July 2004 to lay down regulations relating to the organisation and operation of private Education in Cameroon;
- Mindful of Decree No. 008/3043/PM of 15 December 2008 to lay down modalities for the organisation and operation of private Education in Cameroon;
- Mindful of Decree No. 2011/408 of 9 December 2011 to organise the Government as amended and supplemented by Decree n°. 2018/190 of 2 March 2018;
- Mindful of Decree No. 2011/410 of 9 December 2011 to organise the Government,
- Mindful of Decree No. 2012/267 of 11 June 2012 to organise the Ministry of Secondary Education;
- Mindful of Decree No. 2018/191 of 02 March to organise the Government as amended and supplemented by Decree No.2019/002 of 04 January 2019;

Considering reports of the National Control Brigade for Private Secondary Education Schools (NCBPSES) and information forwarded by the Technical Departments (DGSE, DTVSE, DTT) and external services of the Ministry of Secondary Education,

HEREBY ORDERS AS FOLLOWS:

Article 1: The following private schools or teacher training colleges are hereby closed down from the date of signature of this order in accordance with the provisions of Article 12 of law n°. 2004/022 of 22 July 2004 and of Articles 31 and 32 of decree n° 2008/3043/ PM of 15 December 2008:
